East Coast Halter Futurity acts as a selling agent of the stallion owner and can in no way be held responsible for stallion and/or mare owners inability to get mare bred. Neither the East Coast Halter Futurity nor its Board of Directors shall intervene between the purchaser of the stallion service fee and the stallion owner. All contracts, arrangements and negotiations that arise in the service of any mare designated for the East Coast Halter Futurity will be strictly between the mare owner and the stallion owner. Stallion owner is responsible for listing all fees beyond normal breeding expenses at the time of the auction. Rules to this Futurity are an attachment to this agreement. Please read and keep for future reference.

If the stallion sells for under \$500 owner will have to pay the difference between that and 500 in order to be nominated for that year.

“Stallion owners will get one free entry into the futurity if breeding is sold.”
